



- The manufacturer is not responsible for any failures arising from the use of this product in a manner inconsistent with the technical or safety standards.
- This appliance is intended to be used for nonindustrial use in household and similar spheres of application. Industrial application or any other misuse will be regarded as violation of proper service conditions. Should this happen, manufacturer is not responsible for possible consequences.
- Before installing the appliance, check that the device voltage corresponds with the supply voltage in your home (refer to rating plate or technical data).
- While using the extension cord, make sure that its voltage is the same as specified on the device. Using different voltage may result in a fire or other accident, causing appliance damage or short circuit.
- Always unplug the device after use, before cleaning or moving. Never handle the plug with wet hands. Do not pull the power cord to disconnect from the outlet; instead, grasp the plug and pull to disconnect.
- Use the appliance for its intended purpose only. Otherwise it will be considered as misuse.
- Keep the power cord away from hot surfaces (gas or electric ovens) or sharp edges. Do not let the cord hang over edge of a table or a counter.
- REMEMBER: damaging the cord may lead to a failure that will not be covered by the warranty. If the power cord is damaged, it must be replaced by the manufacturer, after-sales service or similar qualified personnel to avoid possible danger.

- Do not operate the appliance outdoors, to prevent water or any foreign object or insect from getting into the device. Doing so may result in serious damage of the appliance.
- Always unplug the device before cleaning. Follow cleaning and general maintenance guidelines when cleaning the unit.
- DO NOT immerse the device in water or wash it under running water!
- This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. Children shall not play with the appliance. Keep the appliance and its cord out of reach of children aged less than 8 years. Cleaning and user maintenance shall not be made by children without supervision.
- Keep the packaging (film, foam plastic and other) out of reach of children as they may choke on them.
- No modifications or adjustments to the product are allowed. All the repairs should be carried out by an authorized service center. Failure to do so may result in device and property damage or injury.

- 1. Appliance lid

#### Control panel (scheme A2, p. 4)

- 1. On/off button of the device and UV lamp
- 2. The button for adjusting the blowing speed
- 3. The button for setting the device sleep timer
- 4. Operation indicator
- 5. UV lamp operation and ionization functions indicator
- 6. Blowing speed indicator
- 7. Indicator of sleep timer values

# I. PRIOR TO FIRST USE

Carefully remove the unit and its accessories from the packaging. Dispose of all packaging materials and promotional stickers.



Keep all warning labels, warning stickers (if any), and the serial number identification label located on the housina.

After transportation or storage at low temperatures allow the appliance to stay at room temperature for at least 2 hours before use.

Completely unwind the power cord. Wipe the housing with a damp cloth. Ensure that outer and visible inner parts of the appliance are not damaged, do not have chips and other defects. Make sure that all parts of the appliance are installed correctly.

#### II. OPERATION

- Fix the appliance to firm, level and flat location. Selecting the location place for the air purifier. follow the recommendations listed below:
  - · do not fix the air filter close to direct heat source;
  - locate the appliance at least 25-30 cm from interior design items and 1 m from TV and computer equipment.
- 2. Press button, to switch the appliance:
  - the first press switch on the appliance (the operation indicator will light up);
  - the second press switch on UV lamp and ionization function (indicator of the UV lamp and the ionization function will light up);

- the third press switch off UV lamp and ionization function (indicator of the UV lamp and the ionization function will turn off);
- the fourth press switch off the appliance (all indicators will turn off).
- 3. By pressing the 🛞 button, set the required level of air purification intensity from I to III: minimum (I), medium (II) or maximum (III). Switching is performed circle-wise. The set speed indicator will be lit.
- 4. Press the 🕒 button to set the appliance sleep timer:
  - one click 2 hours:
  - two clicks 4 hours;
  - three clicks 6 hours;
  - · four clicks timer deactivated.

The set value indicator will be lit. After the selected period of time, the appliance will automatically turn off.

5. When you finish using the appliance, turn it off and unplug it from the mains.

#### III. CI FANING AND MAINTENANCE

#### General guidelines

Clean the appliance when polluted. Before cleaning the appliance, ensure it is unplugged.



DO NOT immerse the appliance in water or wash under running water!

DO NOT use a sponge or tissue with hard or abrasive surface or abrasive pastes. Do not use any chemically agaressive substances.

Clean the housing with a soft cloth or sponge. You can use mild soap for cleaning. We recommend you to wipe the surface dry to avoid water stains and residues on the housing. Rinse the pre-filter with warm water at least once a month.

#### Filter replacement

Approximate service life of HEPA filter is 2000 hours. When the filter resource is depleted, the operation indicator will flash. To replace the filter, remove the old one and install a new one. After replacing the filter, press and hold the button for a few seconds until the indicator stops flashing.

#### Storage and transportation

Before repeated operation or storage completely dry all parts of the appliance. Store the assembled appliance in a dry, ventilated place away from heating appliances and direct sunlight. During transportation and storage, do not expose the device to mechanical stress, that may lead to damage of the device and/or violation of the package integrity.

Keep the device package away from water and other liquids.
